1.	<p>From Addendum No. 1 <i>Question: Can elevation drawings with measurements be provided for the conveyors in this area</i></p>  <p><i>Answer: APA is reviewing this request and will provide response soon in future Addendum.</i> Addendum No.2 Answer: Please refer to the attached vertical and horizontal clearance information for conveyors 14A, 14B and 35. Sufficient details on conveyors 12A and 12B are already provided with the bid documents.</p>
2.	<p>Question: We request a two week extension to the current closing date of July 12, 2024.</p> <p>Answer: APA hereby extends the project bid closing date from 2:00 p.m. July 12, 2024 to 2:00 p.m. July 26, 2024. The Deadline to submit questions is also extended to July 15, 2024.</p>
3.	<p>Question: We request an extension of four weeks (To August 9th) to provide a complete proposal.</p> <p>Answer: APA hereby extends the project bid closing date from 2:00 p.m. July 12, 2024 to 2:00 p.m. July 26, 2024. The Deadline to submit questions is also extended to July 15, 2024.</p>
4.	<p>Question: Addendum No. 1 issued last week contained the names of 4 local concrete contractors in item 32 but so far 2 of these have declined to bid on precast concrete counterweights. Will it be acceptable for us to solicit bids from other precast concrete manufacturers?</p> <p>Answer: The list of local contractors provided in Addendum No 1 Item 32 represent pre-approved local contractors. Bidders are able to propose from that list or any other qualified contractor(s) for the subject work. Note that other contractors would need to be approved by APA as per contractual requirements during the course of the project.</p>

<p>5.</p>	<p>Question: Please confirm that the highlighted section in the attached tender document excerpt for the bid bond is applicable to both a) and b). Will the certified cheque or bid bond be returned if our bid is rejected?</p> <p>NOW, THEREFORE,</p> <p>(a) If said BID shall be rejected, or</p> <p>(b) If said BID shall be accepted and the Principal shall execute and deliver a contract in the form of Contract attached hereto (Properly completed in accordance with said BID) and shall furnish a BOND for his faithful performance of said contract, and for the payment of all persons performing labor or furnishing materials in connection therewith, and shall in all other respects perform the agreement created by the acceptance of said BID, then this obligation shall be void, otherwise the same shall remain in force and effect; it being expressly understood and agreed that the liability of the Surety for any and all claims hereunder shall, in no event, exceed the panel amount of this obligation as herein stated.</p> <p>Answer: If the Bid is accepted and a contract properly executed, or if the bid is rejected the Bid Bond (or check) will be void. In this case the bid bond is covered by check, APA will either return the check to the Bidder or shred it ... whichever the Bidder prefers.</p>
<p>6.</p>	<p>Question: During our design review of the project specifications, we have encountered technical concerns that will prevent us from submitting a fully compliant bid. Please advise if we are to submit a Base Bid with specific technical exceptions or only a Bid Alternate</p> <p>Answer: As APA’s desire is to receive a compliant proposal (or as close to compliant as possible), the proposal has been updated to reflect three Bid lines.</p> <p>The BASE BID is shall be for a fully compliant proposal.</p> <p>The ALTERNATE BID 1 shall be for “almost fully compliant” with only a few deviations that the Bidder has determined to be mandatory parts of their proposal. Note – if a fully complaint proposal is provided then ALTERNATE BID 1 would be N/A.</p> <p>The ALTERNATE BID 2 shall reflect the Bidder’s proposal to include mandatory deviations (if any), proposed deviations and Bidder proposed alternatives. Note: this proposal is intended for the Bidder to provide your recommended machine / features to APA – with differences from the project documents noted and explained as applicable.</p> <p>The Proposal document page I-9 shall be updated and replaced with the new page I-9 as attached to this addendum.</p>

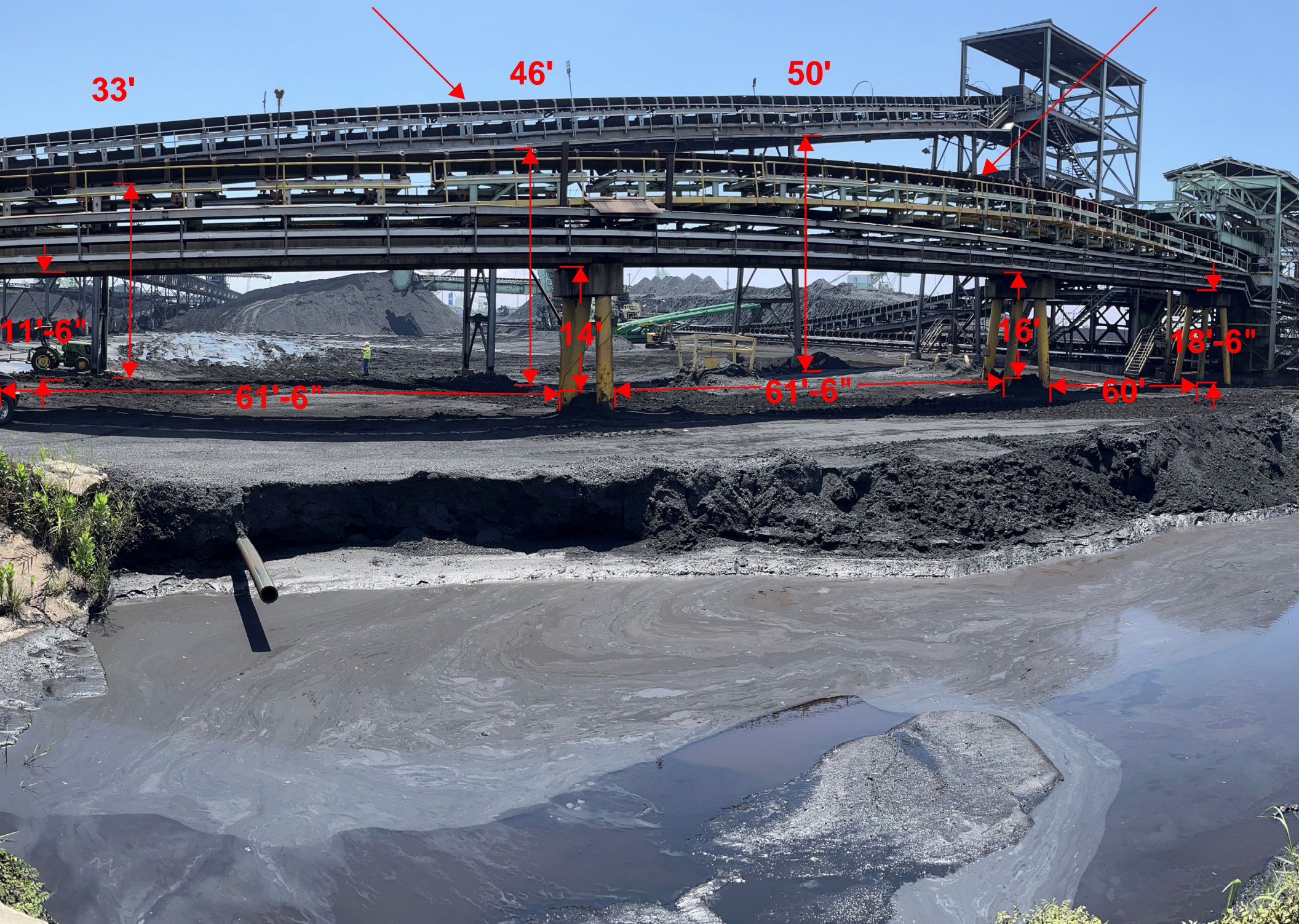
